**Temporary Chair** – To begin the annual LSC organizational meeting, a temporary chair must be elected. Mr. Mulderink was nominated by Mr. Chan. Mr. Evans seconded, and the vote was unanimous in favor.

**Temporary Secretary** – To begin the annual LSC organizational meeting, a temporary secretary must be elected. Dr. Tocci was nominated by Mr. Mulderink. Mr. Chan seconded, and the vote was unanimous in favor.

**Adopt Agenda** – Mr. Mulderink moved to adopted the proposed meeting agenda. Mr. Chan seconded, and the vote was unanimous in favor.

**Chair** – Mr. Chan nominated Mr. Mulderink to serve as LSC chair for the 20015-2016 year. No other nominations were made. Mr. Chan moved to elected Mr. Mulderink. Mr. Evans seconded, and the vote was unanimous in favor.

**Secretary** – Mr. Mulderink nominated Ms. Bahrmassel to serve as LSC secretary for the 2015-2016 year. No other nominations were made. Mr. Mulderink moved to elect Ms. Bahrmassel. Ms. Storrie seconded, and the vote was unanimous in favor.

**Vice Chair** - Mr. Mulderink nominated Mr. Chan to serve as LSC vice chair for the 2015-2016 year. No other nominations were made. Mr. Mulderink moved to elect Mr. Chan. Mr. Zurawski seconded, and the vote was unanimous in favor.

**FOIA/OMA Officer** – Mr. Mulderink nominated Mr. Evans to serve as LSC Freedom of Information Act (FOIA) and Open Meetings Act (OMA) officer for the 2015-2016 year. No

other nominations were made. Mr. Mulderink moved to elect Mr. Evans. Mr. Chan seconded, and the vote was unanimous in favor.

**Meetings for the 2015-2016 School Year** – The LSC discussed and proposed meeting dates for the upcoming year. The committee intentionally shifted the October and March meeting days and times in an effort to make the LSC accessible to a wider range of Coonley community members.

Mr. Mulderink moved to approved the meeting dates. Mr. Evans seconded, and the vote was unanimous in favor.

A special meeting to review and approve the 2015-2016 Coonley budget was tentatively set for Thursday, July 23 at 6pm in the Coonley Library.

**Adoption of Bylaws** – Mr. Mulderink and Mr. Chan will review the LSC bylaws and report back the LSC about any proposed amendments.

**Principal's Report** – Mr. Zurawski updated the LSC on several ongoing items at the school, including:

- The school is seeking funds for further soundproofing in sections of the new addition;
- Seven open teaching positions have been posted tom the CPS human resources website, and there is a particular need for ESL/Bilingual endorsed teachers;
- The installation of air conditioning in the gym is ahead of schedule;
- The administration is reviewing the provisional budget numbers to estimates the impacts on the special education cluster program at the school; and
- The school has a slowly rising balance in its internal accounts that should be discussed at future LSC meetings.

**Adjourn** – Mr. Evans made the non-debatable motion to adjourn. Mr. Chan seconded, and the vote was unanimous in favor.
